12:00PM AGM COMMENCED

Opening Prayer and Welcome

Senior Pastor Duong Huu Dung gave an opening prayer, welcomed the meeting, and introduced the Chair, Barrister David Sanders

Nomination of Minutes Taker

- Mr Van Thua Tin was nominated.
- The Chair asked the congregation to approve Mr Van Thua Tin as the Minutes Taker by a show of hands. Members approved.

Confirmation of Quorum

- 114 of 176 members attended the meeting.
- The Chair declared quorum reached.

12:17PM - Reading and Confirmation of Minutes from Last AGM & EGM:

- Secretary Ve Nguyen summarised the minutes from the 2022 AGM held on 31-07-2022, and the EGM held on 25-09-2022 and stated that the minutes can be found on the Church website.
- The Chair asked the members to confirm the last AGM & EGM minutes by show of hands.
 - AGM July 2022 declared carried.
 - EGM September 2022 declared carried.

12:25PM - Summary of Ministry Report

Secretary Ve Nguyen:

- advised that Annual Report (hard copy booklet) was distributed, and soft copies are available to members upon request by emailing the secretary,
- summarised and highlighted key points.

12:35PM - Financial Internal Audit Report for 2023-2023

Two nominated internal Financial Auditors: Ms Diu Thanh Ngo and Ms Kimberly Dang presented on their audit.

12:40PM - Presentation of the Treasurer on the Annual Financial Statement

Treasurer Pham The Duy Thanh & Deputy Treasurer Nguyen Thanh Tam Chi presented the annual financial statement:

- Documents prepared for the internal auditors and external auditor and relevant government authorities.
- Summary of report, due to members received the copies of the report
 - Income
 - Increased in weekly income
 - Thanksgiving donation increased
 - Total income increased overall
 - Expense
 - Decreased costs in property related costs

- Legal costs expense close to \$195,000, compared to last year of approx.. \$96,000
- Evangelism and discipleship programs increased. This is encouraging as it's a sign its growing
- Fellowship costs involve special programs, events, church camp.
- "Other expenses". Asset depreciation yearly, not used in the calculations, but must be included in the official financial report
- Total expense decreased overall.
- Savings account current balance of around \$157,000
 Consolidated the multiple bank accounts
- Giving thanks to God and for God to help the church to give generously.

12:52PM - Motion to Pass the Annual Financial Statement

- The Chair asked the meeting to pass the annual financial statement by the show of hands.
- The motion was carried.

12:53 – Election of the Church Committee for 2023-2025 Term

The Chair declared the Church committee positions other than Senior Pastor were now vacant.

The Chair informed the members regarding the conduct of the ballot:

- 13 nominated, 10 positions to be covered, every position to be voted
- Person will serve in the position they are elected in
- Secret ballot, no show of hands, no proxy, only members present can vote
- Election officers (EO) to vote first, process will be seen, and the EO assist in the voting process.
- Each member to be given a voting slip leave a blank if you do not wish to vote.
- If a member requires assistance in writing the voting slip, they will notify Dr Thuy (Interpreter) and will make known their vote to Dr Thuy. The Chair asked if anyone needs assistance, no one requires assistance.
- Person with the highest number of votes be elected to the position.
- If two or more people with the same highest number of votes, second ballots for those people
- Acknowledged that the rules are different to the past constitution, however, applying the current constitution.

The Chair read the name of each candidate and asked for the candidate whose name been read out to stand. If at that time they want to say something, they can.

The Chair asked for a recount of the members present and eligible to vote – 113

• Declared the ballot was to proceed.

- Evangelism and Discipleship: Le Hong Phuoc (96 votes)
- Deputy Evangelism and Discipleship: Huynh Thien Quoc Thai (88 votes)

Notes:

- After the ballot for Deputy Maintenance, 2 members left, leaving 111 eligible voting members present.
- After the ballot for Evangelism and Discipleship, 2 members left, leaving 109 eligible voting members present.

2:48PM – The Chair declared all committee positions filled.

- The Chair proposed a motion to confirm only 10 committee members for the new term.
- Declared motion carried by show of hands.

2:50PM – The Chair declared the election complete & AGM complete.
